As a result of this resolution, the governing board of the Bowery Mission gained the ability to appoint the governing board members of New York City Rescue Mission. The resulting business combination was accounted for as an acquisition and consequently the assets and liabilities of the organization were adjusted to estimated fair value on the date of the acquisition. The adjustment of the New York City Rescue Mission's fixed assets to market resulted in an increase in the balance of fixed assets and an offsetting gain of \$15,058,223.

New York City Rescue Mission (NYCRM) has a 147-year history of service to those experiencing homelessness, with roots tracing back to the founding of The Helping Hand on Water Street in the notorious Fourth Ward. In 1962, the organization moved to its present location on 90 Lafayette Street, and in 1998, NYCRM began operating under the name New York City Rescue Mission. In 2011, a generous estate gift marked the beginning of new era of growth, during which NYCRM completed a three-floor expansion of its facility and opened a new shelter for women. Today, NYCRM has the capacity to serve 194 overnight guests, and it serves over 400 meals a day on average.

In the fall of 2017, New York City Rescue Mission became a controlled affiliate of The Bowery Mission (New York City), a 146-year old organization serving those experiencing homelessness across the New York City Metro Area. Today, New York City Rescue Mission remains a distinct legal entity with separate 501(c)(3) tax-exempt nonprofit status, financial accounting, and branding. However, The Bowery Mission has a controlling interest, and provides board oversight, executive leadership, program leadership, administrative support, and fundraising support.

Now called The Bowery Mission's "Tribeca Campus," New York City Rescue Mission's campus at 90 Lafayette continues to serve as a hub for basic needs and emergency services. Additionally, it provides centralized intake for all programs within The Bowery Mission's continuum of care. This location has the capacity to sleep nearly 200 guests on three separate

floors of our building, making it an ideal "front door" for those in need. Serving as a one-stop entry point, it's a place where adults can both have their basic needs met and meet with case workers to discuss their next steps for making progress using our wide array of programs and services.

Daily activities include:

Meal Service: Each day, we serve more than 400 nutritious meals to the community. Meal times include breakfast at 6:30 a.m. (shelter guests only), lunch at 1 p.m., and dinner at 6 p.m.

Safe Overnight Shelter: Our overnight shelter program provides dignified sleeping accommodations for 144 men and 50 women each night. After the 6 p.m. meal, each guest is invited to take a hot shower, receive clean clothing and hygiene products, sleep overnight on a comfortable mattress made with freshly laundered linens, and return to our dining room for breakfast in the morning.

Day Center Activities: In 2018, we launched onsite Day Center programming for guests at 90 Lafayette St. This initiative is designed to provide guests with a safe, hospitable place to go during the day, participate in community-building activities (e.g., classes, support groups), and build trusting relationships with caring staff. Day Center activities are currently provided at 90 Lafayette St. on Mondays, Tuesdays, Thursdays, and Fridays from 9 a.m. to 5 p.m.
